## RFP 1 – Community Hospital

1 – Please clarify the use of the term Diversity in the two sections below? Should each include:

This request is for carrier diversity. Service Providers currently in place:

- Unite
- Spectrum

The HCP would prefer the 100M to be carrier diverse from the 1G Internet. The 100 Mbps is meant to be the back-up.

2 - Can you provide specific bandwidth needs for each location listed below for more accurate quoting?

Please provide variable options that would provide the HCP an opportunity to scale their bandwidth. The HCP is interested in the price range to see if they can upgrade bandwidth within budget.

3 – With respect to the below request: Does the customer desire Ethernet Internet Access (EIA) or Direct Internet Access (DIA)?

The HCP needs to run a SIP product and currently has DIA. If there is a better solution, please present that for review.

4 – Is the request below related to the internal LAN(s) for all locations or just the one listed or for both the LAN and fiber network requested within the RFP?

The HCP is looking for a solution to manage the entire network.

5 – How many SIP trunks needed?

Please provide: 12B+D

6 - Are the current PRIs being converted to SIP?

Not at this time.

7 - Can these be SIP circuits with PRI handoff?

Currently not being used in this manner. Feel free to present this technology.

## RFP 4 – Teller County Public Health

1 – Please specify the number of SIP Channels needed

Please provide options. The minimum would be 48 channels. There is a 10m Internet connection on site. HCP will need new equipment required for SIP/VPN operations. Provide leased and purchase options.

They are interested in minimum 96 strands, but welcome to look at higher options. The routes proposed are suggested. They are open to other routes if it is more cost effective.

HCP is requesting proposals for network management for all services related to the data transport of their network; not compute. Desktops and servers are not covered in the RHC healthcare Connect Fund program. Network management would concentrate on circuit and equipment monitoring, uptime and security for the network.
