- Data provided will result in summary reporting at the local, regional, and state level and maps and visualizations that will be shared routinely

- CDPHE Office of Emergency Preparedness and Response (OEPR) has developed a standardized process for gathering information through EMResource for enhanced statewide situational awareness
- The Assistant Secretary of Preparedness and Response (ASPR) has requested that states gather specific elements of information
- OEPR has taken these Essential Elements of Information (EEIs) and worked on merging and streamlining the requests for reporting by epidemiologists, LPHAs, and Health Care Coalitions (HCCs)
