## Session One – Updates on COVID-19 Rules and Responses

## Session Two – Out-of-Network Payment and the No Surprises Act

As of Jan. 1, 2022, Colorado hospitals will be subject to two sets of laws designed to protect consumers from surprise billing – the state’s out-of-network legislation, passed in 2019, and the federal “No Surprises Act,” passed in 2020. While targeting the same core issue, the laws take different approaches and require various compliance approaches. Experts from CHA and Polsinelli will discuss what we know – and what we don’t know – about how providers need to ensure compliance with the laws in 2022.
