

- Progressives grow their ranks in the Democratic caucuses





Join coalition partners to streamline hospital discounted care programs, ensure patient access to critical medications and expand access to remote patient monitoring services in Medicaid

 HCPF is pursuing a bill to eliminate CICP and instead move the program requirements into rule. This would mean that hospitals would not be held to the CICP reporting standards, but would need to continue offering the more generous, copayment requirements under CICP. With this comes an opportunity to support this effort and attempt to streamline the operational burden for hospitals created by HB 21-1198.

Elimination of CICP



 Legislation will be introduced in 2023 prohibiting state-regulated health insurance plans from requiring hospitals and providers to designate pharmacies based on network participation, rather than proximity and quality. CHA's Advancing Value Task Force has recommended supporting legislation to prohibit whitebagging in Colorado.

Prohibit Whitebagging Colorado Medicaid only permits reimbursement for remote patient monitoring (RPM) under "home health telehealth" services. The Colorado Rural Health Center will be pursuing legislation expanding the list of eligible providers for RPM reimbursement under Colorado Medicaid and to provide grants or funding support for rural health clinics to purchase RPM equipment.


Hospital financial outlook is deteriorating rapidly

Colorado hospitals and health systems are national leaders

- 17 major reforms being implemented in Colorado
- Hospitals and state agencies struggling to achieve deadlines

- While 2021 financial markers were strong, 2022 performance on trend to be worst in recent history
- Trusted national analysts downgrading outlook due to workforce, inflationary pressures; highlighting long-term structural problems
- Colorado's health care system ranks as the top state in the region and 12th best State in the U.S. for health system performance including measures of quality, access, affordability, and treatment

Detail: Hospital Finances



After rebounding in 2021, patient discharges have decreased by 1.1% in 2022 and 6.1% from pre-pandemic (2019).



Length of stay continues to increase, up 2.5% from 2021 and 13.9% from 2019.

The Colorado hospital industry is experiencing significant changes in operating margins, down 49% to a statewide average of 5.2%.



Patient revenues are not keeping up with expense increases, which are up 3.5% from the prior year.

Margins are impacted by operating expense increases, up 10.3% from 2022, and driven by a 17.4% increase in payroll expense and 7.2% increase in supply expense.



Total margins have decreased over \$2 billion in 2022 to a statewide average of 0.2%.

Detail: Colorado Hospitals Leading the Way



AFFORDABILITY

- In 2020, Coloradans spent \$4 billion less than the national average on hospital care.
- Colorado households spend the second lowest amount on hospital costs in the country.
- Hospital costs in Colorado are now 18% lower than the U.S. average and are rising at a slower pace than national trends.
- In the last 10 years, Coloradans have saved \$22.5 billion dollars through lower hospital costs, compared to the U.S. average.

ACCESS

- Patients have access to some of the top hospitals in the country for providing clinical excellence, according to Healthgrades, with three hospitals in the top 1% of all U.S. hospitals, five hospitals in the top 2% of all U.S. hospitals, and 12 hospitals in the top 5% of all U.S. hospitals.
- Colorado hospitals are an integral part of the health care system in Colorado that ranked the top state in the region and 12th best state in the U.S. for health system performance including measures of quality, access, affordability, and treatment.

QUALITY

 Colorado ranks as the 6th best state in the nation for prevention and treatment and 4th best in the nation for avoidable hospital use and cost according to the most recent Commonwealth Fund Scorecard on State Health System Performance

Economic Factors - September Forecast

- Inflation growth remains elevated
- General Fund revenue revised down through FY24 on lower income and sales tax revenue
- Total revenue expected to fall 6.1% in FY23, rebound slightly in FY24

Gov. Polis Budget Presentation – Nov. 2

- \$70 million provider rate increases; \$75 million backfill increases in home care (expired ARPA funding for \$15/hr min)
- 0.5% across the board rate increase
- Elimination of all Medicaid copays (except ED); providers will have effective rate increase
- Increases to nursing homes, based on payer mix tiering. More nursing homes have gone bankrupt this year than in last 10 years combined.
- Rural providers would receive annual, ongoing funding to connect to health information exchange -- \$100K/yr for critical access hospitals, \$20k/yr for rural health clinics
