General RFP Question for all applicable HCPs:

Your RFPs mention the end user may be interested in services like managed services and MDR. Since this language tends to be consistent across all RFPs, would it be possible for you or someone on your team to send a quick email when an end user specifically expresses interest in these services? We often don't see any clear indicators in the requests themselves that signal genuine interest, so a heads-up would help us process those requests to better help the end users.

Unfortunately, no, we cannot do that as a direct email to a single vendor that could potentially give them an advantage in their RFP response would constitute a competitive bidding violation. The best advice in this situation would be to include an MDR/EDR option in your response. While we understand that it is difficult to prepare an exact bid based on the general request included in the RFP, perhaps a note that indicates that if an HCP needs those services/tools, you have options available that could meet those needs.

Ultimately, if a vendor bid is selected, conversations to refine the offering can be undertaken as you work with the awarding HCP to generate a quote or contract for services that CHABS will use to request funding.

Please keep in mind that the purpose of bidding on an RFP for the requested services is twofold: one, to provide a specific outline of costs for those services that are specifically listed in the RFP document but, two, to provide a response where specificity is not offered in the RFP document that demonstrates your capability to meet those needs generally. Again, with the idea in mind that if you are a winning bidder for a specific RFP, you can then work with the HCP to refine costs and services after award.

While cost is our highest weighted RFP scoring factor, we also look at additional factors included in the RFP document that also contribute to our overall cost effectiveness score. Suitability to meet HCP needs is one of those requirements. Additional information on our scoring rubric can be found in the RFP documents. All of that is to say that while an RFP response may be compelling from a bottom-line cost perspective, if the vendor submitting that bid does not demonstrate a high level of overall capability to meet an HCP's needs, that is considered in the cost effectiveness score. In other words, costs may be good but if the vendor overall does not seem to possess the capabilities that would best meet the HCP's needs, we take that into account. Rationale here being that lowest cost but high risk in terms of capabilities could result in much higher costs as the HCP is forced to engage in remediation or complete vendor change due to bad fit.

RFP 07 - St Vincents Health

- For the Wireless Access Points, did we have guidance on coverage requirements and structural cabling needs? The HCP already has everything they need to install the access points so cabling and coverage were already considered in the number of devices the HCP requested in the RFP.
- For the switches do we know if they are in multiple IT closets? If so, what types of interconnects are available or needed to be installed? The switches will replace end of life devices, so internal connectivity is already in place and does not require installation from that standpoint. The mention of installation and configuration costs in the RFP is directly related to the professional services that would be required to install the equipment in their predetermined locations and configuration to ensure they are operating properly on the network.
- Will any of the switches need to be virtually stacked? Not to my knowledge. Any stacking will be done physically.
- Do the switches require 10G uplink for interconnects or are 1G uplinks sufficient? 10G is not specified in the RFP so 1G is sufficient.
- Is there a need for an aggregation switch? Aggregation is not specified in the RFP. Assumption is that HCP will determine how to aggregate with network management MSP.

- Physical address location of DMARC? Location is specified in the RFP.
- Has an MNE Services provider already been predetermined? No services are predetermined as that would constitute a competitive bidding violation however, the HCP is under contract with a network management professional services provider who may provide installation and configuration as a part of their contracted scope of work however any bids that present a lower cost option will be considered with the understanding that other bid factors other than price will be taken into account.
